- A fee of £150 (including VAT) per race day is payable to register an Alternate Operator (payment <u>only</u> by telephone using a debit/credit card on 01484 448200).
- 7. Failure to comply with these terms and conditions will result in the application to register an Alternate Operator being declined. Alternatively, where appropriate and without warning, the Alternate Operator may be stood down by the BRM.
- 8. Please note that we require the information and documents requested in this form in order to ensure that there is compliance with s.92 of the Gambling Act 2005 and with clause 4.4 of the Racecourse Licence Agreement in operation at most racecourses. RBC will hold all records in compliance with all provisions of the Data Protection Act 1998. These records may be made available to appropriate authorities by RBC Ltd.
